- e. Develop and provide training materials.
- f. Provide certificate on successful completion of projects.

## 6. Force Majeure

In the event of non-fulfillment of the contract terms and conditions due to any reason of force majeure namely fires, wars, riots, strikes, natural calamities, etc., neither Epitas nor AJIET shall be held responsible for any loss or consequential loss.

# 7. Indemnity

The AJIET hereby agrees jointly and severally to indemnify Epitas, their representatives, administrators and properties from and against all action, demands, proceedings, prosecutions, and the like arising out of its liabilities and all charges, taxes, etc.

Similarly, Epitas shall be liable to indemnify/compensate the AJIET on account of any losses arising due to the fault of Epitas.

- 8. The AJIET shall ensure that all its software is legal. Epitas shall not be responsible in any way for any liabilities arising out of use of pirated software.
- 9. Epitas will be one of the authorized parties for patenting the products developed at the innovation center along with AJIET.

## 10. Breach of Agreement

Epitas shall have the right to terminate the agreement with the AJIET, in case the AJIET either fails to provide the mutually agreed services successfully as mentioned in the MOU, or exploits the students or misuses the partnership with Epitas in any way.

### 11. Amendment to the Agreement

The obligation of the AJIET and Epitas have been outlined in this agreement. However, during the operation of the agreement, circumstances may arise which call for alteration or modifications of this Agreement. These modifications/alterations will be mutually discussed and agreed upon in writing.

# 12. Period of Validity

## 14. Pricing

Epitas encourages students to enroll for certified internship program. This internship program will have the nominal fee of Rs 6,000 per month plus GST as applicable for Non-AJIET students. We offer a discount of 15% on the basic price exclusively for AJIET students.

We propose to share a margin of 25% on each internship registration to AJIET institution plus taxes applicable. Epitas will make this payment on monthly basis based on the invoice raised by AJIET.
