WHEREAS the parties to this agreement are desirous of encouraging students who are pursuing an education in the field of engineering domains to involve in research activities with the aim of bridging the gap between academia and industry have agreed to establish a programme under the name and style of "MARIAN – AJIET" which shall be a joint initiative between the parties hereto.

AND WHEREAS the parties with the objective of achieving the goals herein before mentioned have reduced to writing the terms and condition which are described in more detail hereinafter in this memorandum, which shall govern the relationship between the parties hereto.

NOW THIS MEMORANDUM WITNESS AS FOLLOWS

SCOPE OF THE AGREEMENT

This MOU details the modalities and general conditions regarding the programme, to make available highly qualified manpower in the areas of Civil Engineering without any prejudice to prevailing rules and regulations in AJIET and Marian Projects Pvt. Ltd. without any disregard to any mechanism evolved and approved by the component authorities under government of India in so far as much mechanism applies to AJIET and Herumba Consultants. The areas of cooperation can be extended through mutual consent.

RESPONIBILTIES OF THE PARTIES

- a) Both AJIET and Marian Projects Pvt. Ltd. shall encourage interactions between the Engineers, Scientist, Research fellows, faculty members and students of both the organizations through the following arrangements:
- b) Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon;
- c) Organization of joint conferences and seminars;

- d) Practical training for students of AJIET at "Marian Projects Pvt. Ltd."
- e) Joint guidance of student at mutually agreeable terms.
- f) Marian Projects Pvt. Ltd. would accommodate BE students who have completed the 6th semester of their programme in such a number that it deems convenient to it for the purpose of imparting industrial training.
- g) Marian Projects Pvt. Ltd. may depute its personnel as visiting faculty at AJIET to teach any of the regular Course or specialized topics.
- Marian Projects Pvt. Ltd. may seek assistance / guidance of AJIET faculty member /s in product/process modification, modernization, troubleshooting, etc.
- Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument. Etc.
- j) Marian Projects Pvt. Ltd. may avail library, Internet, Computational facilities at AJIET.

AMENDMENTS

Any amendments and/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGTEEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendments or addenda.

EFFECTIVE DATE AND DURATION OF MOU

- a) This MOU shall be effective from the date of its approval by the competent authorities at both ends.
- b) The duration of MOU shall be a period of 3 years from the effective date.
- c) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a programme under the MOU.
- d) Any clause or article of the MOU may be modified or amended by mutual agreement of Marian Projects Pvt. Ltd. and AJIET.
